Former Diamondback Luis Gonzalez Joins ALBWS

Baseball stars Jeff Kent and Luis Gonzalez will add their lively commentary to the first live webcast of The American Legion Baseball World Series in Fargo, N.D. They will join play-by-play webcaster Jim Darby and coanchor Bill Haase, former Detroit Tigers

executive and senior vice president for the Baseball Hall of Fame and Museum in Cooperstown, N.Y.

The 15-game series, to be played Aug. 14-18, will be webcast exclusively via live video stream on The American Legion's Web site www.legion.org/baseball.

Kent played six seasons (1997-2002) with the San Francisco Giants, usually batting behind Barry Bonds. He drove in 90 or more runs each year for the team and was named

the National League's Most Valuable Player in 2000. He played high school baseball in California and was drafted by the Toronto Blue Jays in 1989.

On Oct. 2, 2004, Kent surpassed Ryne Sandberg of the Chicago Cubs as the second baseman with the most home runs, hitting number 288 out of the park.

Gonzalez played baseball for American



Legion Post 248 in Tampa, Fla., before moving on to the big leagues. He starred as an outfielder with the Arizona Diamondbacks, hitting 57 home runs in 2001. That same year, he drove in the winning run of Game 7 in the World Series, giving Arizona the championship.

On May 22, 2004, Gonzalez slammed career hit No. 2,000 against the Florida Marlins; two years later, he reached 500 career doubles.

Kent and Gonzalez are both five-time members of the Major League All-

Star Team Kent will work the microphone for Legion World Series Games on Saturday, Aug. 15 and Sunday, Aug. 16. Gonzalez will cover the final two days of the series on Monday, Aug. 17 and Tuesday, Aug. 18.

When they began to want their rights recognized, they made a flag of thirteen stripes (showing they were united) but with the Union Jack showing they still wished to be loyal to England. When it became necessary to fight for their freedom, a flag of thirteen alternate red and white stripes and thirteen

All over the colonies, people wanted a new flag and since they only had a verbal description, many variations emerged. The stripes were easy to visualize, but the stars on a blue field came out in many different forms; a circle of 13, a circle of less with stars in the corners, a star pattern, a horseshoe, etc.

Washington had a sketch of the flag originally with six pointed stars (easy to make). The seamstress asked why use the stars of our enemy (England) when we could use five pointed stars of our friends (French).

Originally, it was intended to add a new star and a new stripe for each new state. When two new states were added we had our only flag of more stripes (15). It could be seen that this would not work. The Congress went back to 13 stripes to always represent the original 13 states and added a new star for each new state until the present 50 was achieved.

This has become our most sacred symbol. It is draped over caskets of men and women killed defending our way of life. National Commander Rehbein asked, "shouldn't a symbol so sacred be protected the same as a U. S. mailbox and a dollar bill?"

Twenty years have gone by since five United States Supreme Court Justices took away our right to protect the U.S. Flag. We must continue to fight to gain this right back. It takes much time and effort but it is worth it no matter how long it takes.

My Dad went to Korea and fought for our country when he was only 17 years old. He spent three days on a submarine to get there. Everybody jumped off the bridge and no one saw each other again.

Earl E. Mitchell American Legion Post and Unit #29 Win Richard H. Bieri Memorial Cooperation Trophy

For the year 2008-2009, Unit and Post 29 accompanied, participated in and actively worked jointly primarily in Veterans Affairs and Rehabilitation. Each month, on the first Friday of the month, we treat a group of [16-20] residents from the VA Home to free dinners and non-alcoholic beverages. During this monthly event, the residents get to share conversation and enjoy live music.

In July, we held a Watermelon Bash at the VA State Home, with hot dogs and hamburgers. The whole family participates in this—Legion, Auxiliary and S.A.L.—with each faction contributing their own part, including donations of toiletries, books, games and whatever items the residents can use to make their lives less lonely.

Post and Unit 29 solicit for donations of funds and toys for Glendale's Heart for the City, an organization that furnishes needy children and their families with food and supplies. In August, we collected school supplies and backpacks for these children.

The Post donated the recreation hall to Heart for the City for purposes of fund raising with "Casino Night". During this event, Legion, Auxiliary, S.A.L. and A.L.R. members were able to mix with the community during a night of fun and frivolity.

On September 11th, we provided free lunches for our Glendale police, fire and EMT groups, in commemoration of 9/11. This includes food cooked in the Post kitchen and desserts donated by the Auxiliary, Legion and S.A.L.

In October, we jointly commemorated the POW/MIAs with the Post's annual ceremony.

For Halloween, we participated in District 11's Military Night at the Fear Farm in Avondale. Our Post and Unit donated hot dogs and soft drinks. The Legionnaires and S.A.L. did the grilling; the Auxiliary did the serving. These refreshments were distributed free of charge to all those who partook. Also, on Halloween, the Post and Unit manned game and activity booths for children at Sahuaro Park. We used this as an opportunity to furnish and distribute Halloween Safety brochures and coloring books to the children.

In November, we furnished the residents of Victory Place, in Phoenix, with a Thanksgiving dinner. Turkey, stuffing, potatoes, salad and pies were served to approximately 100 residents and staff. We collected new clothing and personal items, including toiletries, books, videos and games to give to them, along with phone cards so that they could make local and long distance calls to family and friends over the holidays. The Unit purchased new flags for the residents' flag poles. The Color Guard and Honor Guard held a flag raising ceremony.

In December, Post, S.A.L. and Auxiliary members volunteered to work at the VA Gift shop. We also held a special Military Family Christmas event. In order to fund this, the Auxiliary held a special fundraiser in October, obtained names of six active duty military families who are in need; then we went on a heavy duty buying spree to purchase gifts, grocery gift cards, toys, cookies and candy to enable the families to have a real Christmas with all the trimmings.

We held our annual Children's Christmas party. Post 29's Adjutant was Santa Claus to our Unit's 2nd Vice Mrs. Claus. The American Legion Riders Chapter 29 provided safe motorcycle rides for the children. The children also enjoyed snacks, games; and each child received a gift.

In February we held our annual Valentine's Day dinner and dance. This event is to raise funds for the AEF. We can always count on the Legionnaires and S.A.L. members to cheerfully purchase tickets and bring their sweethearts to the function. The Legionnaires also helped serve the dinners.

Every March, we get together and assemble Poppy packages to be mailed out. The Legion prints the letters and envelopes, free of cost, for the Auxiliary, then a group of Legion, S.A.L. and Auxiliary members get together to fold, stuff and label the envelopes for mailing. The Legion provides bulk mailing privileges in order that we may mail over 2,100 poppy envelopes out to our members at low postage rates.

In April, we hosted an Easter party for children. The S.A.L. and Legion members cooked hamburgers and hot dogs. The Auxiliary provided games, snacks and Easter baskets for each child. The children also enjoyed face painting, cookie decorating, and a piñata at the end of the party.

Post, S.A.L. and Unit 29 participated in flag disposal ceremonies, not only at Post 29 but at other locations such as Sunland Memorial Park and one in Buckeye. We support each other with our Boys and Girls State programs. The Legion Honor Guard donated enough money to our Girls State program to fund two girls.

The Unit furnishes decorations, cake and other food for all patriotic holiday potlucks. This past Memorial Day, the S.A.L. provided hamburgers and hotdogs for the potluck; the Auxiliary and Legion members provided side dishes. The Post paid for the live music.

We jointly support the Color Guard in parades, attend funerals with the Honor Guard, and pass out poppies to those in attendance. During "membership drives", the Legion, S.A.L. and Auxiliary set up tables at different locations, including the jazz and chocolate festivals at Murphy Park, to encourage people to join The American Legion Family. We distribute poppies during these events.

The Unit also purchased an American flag, a state flag and a POW/MIA flag for the Post home when the current ones needed to be replaced.

In April, the Post 29 Service Officer organized a picnic for the residents of the VA Home. Legion, S.A.L. and Auxiliary members donated food and time to bring this event to fruition.

Starting in May, the Unit and Post presented over 30 school and JROTC awards to deserving students at 20 schools. This project ended the first week of June.

Also in May, we all participated in a cook out at Victory Place. Hot dogs and hamburgers, soft drinks and chips were given out to the residents. S.A.L. and Legion members did the cooking; the Auxiliary did the serving.

We have encouraged people to vote, and helped register those who were not yet registered.

We purchased and distributed pocket flags to our military people. We helped collect clothing and personal items for citizens in Iraq.

The Auxiliary helps the S.A.L. each month with the S.A.L. breakfast and annually with the S.A.L. Mother's Day breakfast.

The Legislative Chairs for Legion and Unit 29 sent letters to senators, congressmen, and local politicians regarding Veterans benefits. We applauded those bills that promoted the welfare of our veterans and active military personnel. Conversely, we denounced those bills, proposals and announcements that were detrimental to our veterans, i.e., the document generated from Homeland Security classifying returning soldiers as "terrorists" and President Obama's proposal to charge our veterans for their medical treatment of service-related illnesses and injuries. We sent letters to the editors of local newspapers with the intent of educating the public about veterans' benefits.

In addition to our membership drives, we attempt to "meet and greet" people in order to bring to their attention the plight of our veterans and the advantages of belonging to The American Legion family.

Post 29, Auxiliary Unit 29 and S.A.L. Squadron 29 work closely together, often crossing over into each other's programs without even realizing it. We have a solid marriage of sorts, and a very happy family with our Sons and Riders.
