Bills Impacting Veterans/Military

HB2670 Bill Title: State agencies; veterans status; inquiry (AGENCY-SPONSORED BILL- POLICY POSITION: SUPPORT)

Requires all state agencies, boards, commissions and other administrative units of Arizona (agencies) to ask all individuals "Have you or a family member ever served in the military?", and to provide specified veteran's information for those who answer in the affirmative. Amended: Includes Space Force in the definition of Armed Forces of the United States and appropriates \$50,000 for costs associated with change (flags, branch seals at Veteran Homes, Memorial Cemeteries, etc.) Amended: Removed lines 6 through 16 language requiring state agencies to "ask the question" and replaced with the Burial Equity and Reserve Act language, which allows ADVS to provide burial services in state veterans' cemeteries for eligible members of the Arizona National Guard and the United States armed forces reserves and provides a \$15,000 annual appropriation.

Senate Bills

SB1136 Bill Title: housing grants; military; veteran; homeless

Striker: Amends ARS Section 1. Title 41, chapter 37, article 2 by Creates the Housing Grant Program (Grant Program), under the Department of Housing (DOH), to construct military transitional housing, veteran housing, affordable housing or homeless housing (Program Housing) with grants awarded to for-profit or non-profit companies and organizations, municipalities or counties or consortiums of municipalities and counties using renewable building materials, innovative building materials and renewable energy and innovative energy for utilities. Adopted amendment: Directs monies in the Military Transitional Housing Fund to also be used for constructing a transitional comprehensive care facility that provides specified housing and health services for military members transitioning into civilian life and includes sober living facilities/programs. Allows legislative appropriations to be deposited into the Military Transitional Housing Fund. Repeals program January 1, 2029.

SB1145 Bill Title: Student activity fees; conscience exemption

Amends ARS Section 15-1626 relating to the Arizona Board of Regents. Creates an exemption from the requirement to pay student activity fees if the payment of such fees would violate the students conscience or at minimum meets

SB1454 Bill Title: Veteran suicide prevention; pilot program

Amends ARS Title 41 Chapter 3, Article 7 by adding Section 41-610.02 and repeals Section 41-610.02. Appropriates monies to the Arizona Department of Veterans Services to create a suicide prevention pilot program which includes creating a curriculum to train and certify claims examiners and county and municipal veteran service offices in suicide prevention. Requires the Department of Veterans' Services to send an annual report to the legislature.

SB1466 Bill Title: Medical marijuana; adult-use marijuana

Conforms various recreational and medical marijuana laws related to the sale, packaging, labeling tracking and advertising of marijuana and marijuana products. Includes post-traumatic stress disorder and autism spectrum disorder in the list of medical conditions qualifying a patient for a medical marijuana registry identification card. Contains requirements for enactment for the affirmative vote of at least three-fourths of the members of each house of the legislature. (Proposition 105). Adopted amendment: Exempts honorably discharged veterans of the U.S Armed Forces from the medical marijuana registry identification card application fee.

Amends ARS Section 15-1809 relating to classification of students for tuition purposes. Expands eligibility for the spouses of military veterans tuition scholarship fund to include surviving spouses who have not remarried and requires the Arizona Department of Veterans' services verify the person is a surviving spouse that has not remarried. Amended: Combines language from SB1206- Includes language to allows tuition waivers to be used at degree-granting private post-secondary institutions in this state that are approved by the Arizona Department of Veterans Services (State Approving Agency).

HB2336 Bill Title: Tuition; family; posttraumatic stress; suicide

Amends ARS Section15-1808 relating to postsecondary institutions. Requires the Arizona Board of Regents (ABOR) and Community College District (District), after verification by the Arizona Peace Officers memorial Board, the Arizona Fallen Firefighter Memorial Committee or the Arizona Department of Veterans' Services, to provide tuition waiver scholarships to a child or spouse of a person who meets the following criteria:

The person:

- Was a Veteran of the United States Armed Forces or serving or previously served as a peace officer, firefighter or member of the United States Armed Forces at the time of the person's death; It is not a requirement that the person was employed as a peace officer or firefighter or was serving on active duty as a member of the United States Armed Forces at the time of the person's death.
- Was a resident of this state at the time of the person's death;
- Suffered a post-traumatic stress (PTS) injury in the line of duty; and
- Died by suicide.

Specifies that a person meets the above requirements on the effective date of this Act is eligible to receive a tuition waiver scholarship as prescribed regardless of the date on which the eligible person's parent or spouse suffered the PTS injury and died by suicide.

SCR1006 Bill Title: Death benefits; assault; first responders

Completed Legislative Action - HCR2025 (Mirror)

Enacts and orders the submission to the People of a Measure relating to First Responders- "Back the Blue Act". Upon approval of the voters and proclamation of the Governor, through December 2032, an additional 2% surcharge will be added on every fine, penalty, and forfeiture imposed and collected by the courts for criminal offenses. Creates the "State supplemental benefit fund" and payment of death benefit of \$250,000 to the first responder's surviving spouse or evenly split amongst surviving children. Further defines "first responder" to include Arizona National Guard Members on state active duty and correctional officers employed by Arizona Department of Corrections. Intent is to increase the criminal penalties against persons who assault first responders in this state and to increase the death benefits for the families of first responders who are killed in the line of duty in this state. Directs the Secretary of the State to submit this proposition to the voters at the next General Election.

Requires parties to notify the county assessor if there is an event that disqualifies the person or property from exemption. SB1207 Bill Title: Veterans' donations fund; grants; annual report

Striker: Amends ARS Section 41-608 relating to the Arizona Department of Veterans' Service Veterans' Donation Grant Fund. Directs the department not to deny or refuse to award a grant to an applicant if they have been a previous recipient, award \$2million or the balance of the fund (whichever is less), publish a list of all grant recipients on the website and send an annual report on the number of veterans who received services through organizations that were warded grants.
